| 1.2 | 27.4 | Right | across bridge to stay on Rd 29 (at dirt road 22H) (E) |
| 3.4 | 30.8 | Left | Rd 27 (N) to Masonville |
| 3.3 | 34.1 | Right | Rd 38E (E) in Masonville |
| 5.9 | 40.0 | Left | Rd 23 -- Centennial Dr -- over dam -- Horsetooth Reservoir |
| 1.6 | 41.6 | Left | stay on Rd 23 at Jct. Rd 42 -- CAUTION: 2x CATTLE GRATES AHEAD |
| 4.4 | 46.0 | Right | Rd 52E in Bellvue (W) |
| 0.9 | 46.9 | Left | Rd 54G in LaPorte |
| 1.8 | 48.7 | Left | US-287 / Hwy 14 |
| 1.0 | 49.7 | Left | CHECKPOINT: Hwy 14 at Ted's Place -- towards Poudre Canyon |
| 10.0 | 59.7 |  | Poudre Park - grocery |
| 3.8 | 63.5 |  | Mishiwaka - restaurant |
| 2.5 | 66.0 | Left | Rd 27 - to Stove Prairie and Masonville |
| 5.2 | 71.2 |  | Stove Prairie -- Jct. Rist Canyon Rd. |
| 15.4 | 86.6 | Right | Rd. 27 in Masonville |
| 3.3 | 89.9 | Left | Rd. 29 (W) |
| 3.4 | 93.3 | Left | Rd. 29 at bridge |
| 1.2 | 94.5 |  | US-34 |
| 5.2 | 99.7 | Left | Becomes Rd 12 (E) |
| 1.9 | 101.6 | Right | Rd 23 (S) -- becomes Hwy. 56 |
| 2.4 | 104.0 | Left | Hwy. 56 turns east, diverging from Rd 23 |
| 2.6 | 106.6 |  | Kwik Corner convenience store - after jct. US-287 |
| 1.4 | 108.0 |  | US-287 forks away from Hwy. 56 in Berthoud -- cont. straight on Hwy. 56 |
| 4.9 | 112.9 | Right | I-25 Frontage Rd. (S) -- Cross over I-25. |
| 6.8 | 119.7 | Left | Mulligan (E) |
| 0.3 | 120.0 | Right | Mead (W) |
| 0.3 | 120.3 | Right | FINISH: Lot NE of I-25 exit 243 (Colo. Hwy. 66) |
